3. General information and detail of Connected Transaction

Nong Suea Chang Chonburi Co., Ltd., which is a juristic person whose directors of the juristic person hold the same major shareholder and SF (2513), has agreed to enter into a contract to rent a pineapple plantation area in a total of 2,143-1-67 rai located at Nong Suea Chang Subdistrict, Nong Yai District, Chonburi Province with the rate of 3,000 baht/rai/year, period of the agreements 3 years which a total amount 19,287,000 baht.

Payment Terms: The rental is to be paid two times per year within 15 June and 15 December of every year by paying 3,214,500 Baht/time

4. Total Transaction Value

The above transaction value amounts to 19,287,000 Bath if such transaction is included together with the similar type of transaction occurred in the previous six-month period on January 1,2021,

in the amount of 4,292,668.75 Baht, the connected transaction is totaled of 23,579,668.75 Baht. They shall be considered as Connected Transaction, according to Notification of Capital Supervisory Board Tor Chor. 21/2008 Re. Rules on Connected Transaction and Additional Amendment as a short-term rental. After calculation the transaction size, the connected transaction size is 1.512% of NTA as of December 31, 2021, which is higher than 0.03%, but less than 3% of NTA the value of this transaction is categorized to be medium size transaction and to be approved by the Management Committee and revealed to the Stock Exchange of Thailand.
